The WA3SH expedition to Clarion County, despite some last minute cancellations due to work or illness by some of the operators, was a lot of fun. A six person crew — N3SBF NOVLR W3RJM W3SRL W3WH and WN3VAW — activated WA3SH from N3SBF's cabin on October 9th to the tune of 207 QSO's, 63 counties worked, and over 20,000 total points, making sure that no one could say that Clarion was hard to find. In addition, W3SRL and W3WH went out as one mobile team to activate Forest, Elk, and McKean counties — yes, it's hard to believe, but Bill actually worked HF SSB! At the same time, N0VLR, WN3VAW and the WACOM mobile antenna tower (thanks again WACOM!) set up as a Rover tandem in Forest, Clarion and Jefferson counties — and got some nice ad hoc Amateur Radio publicity down at the Cook Forest State Park Fire Tower parking lot, too!

It has been brought to my attention that there was an error in the transcription of the minutes of the September, 1999 meeting of the Wireless Association of South Hills, Inc. This was inadvertantly published in the club newsletter, and caused a certain amount of embarrassment to one of our members.

On review, I have determined that my transcription DID NOT convey the intent of the Speakers's message. I'd like to submit this CORRECTED transcription of that portion of those minutes:

iamvention* Let the Gouging Begin!

Dayton Hamvention / ARRL National Convention are appearing.

Two Motel 6 locations, Dayton North (Miller Road) and Dayton Northwest (Englewood) have informed amateurs with reservations that the single room rate has gone from \$29 to as much as \$73 per night. Dayton North has requested payment in advance with the confirmation, money order or credit card only (no personal checks), and in their letter states that the reservations will be accepted only for all three days/nights of the Hamvention.

Both of these motels have had recent reputations for problems. Both have conveniently lost reservations for amateurs over the last few years. Dayton North overcharged one cash-paying amateur last year, and did not fully refund the difference when it was pointed out to them. Some amateurs staying at Dayton Northwest last year had extraneous charges post-Hamvention show up on their credit cards, which at last word were still in dispute.

If you have reservations with these or other Dayton hotels, check to make sure they are still valid and that the rates haven't suddenly skyrocketed on you. Meanwhile, WN3VAW, KA3UPY & KD3JB have made other arrangements with University of Dayton housing.

Skyhooks: HF Antennas on a Shoestring

In last month's edition of the WASHRAG I described a relatively inexpensive multiband HF antenna, the OCF dipole. Well, compared to the OCF antenna, this month's feature is EXTREMELY modest. Modest enough to actually be called cheap. Effective enough though to be called a WINNER. This month's shoestring anntenna feature is a variation on the longwire.

Back in my younger days as an Army Combat Signal Team Chief, and later as a Battalion Communications Chief, I was constantly challenged to find a compact, easy-to-deploy and most of all, an effective antenna to be used on the upper military HF bands. The frequency range was 15-20 MHz AM and RTTY, and occasionally we used VHF in the 32-50 MHz range for local communications.

Well, if you think you have problems with low hanging tree branches and parking garages, I'd like to take you for a short little tank ride! We managed to break every whip antenna in my company in a single afternoon once! Not to big of a deal when we were close together, as in a convoy since we hardly needed antennae then. It was when we broke up to hide in the woods that we needed the added range of a good antenna.

Enter the AB-634A/G longwire.

This antenna, hereafter referred to as the 'Army Longwire' is compact enough to drop in your pants pocket yet effective enough to use as your primary portable antenna. It is simply 300+ feet of very flexible braided copper wire reeled up on a standard openface fly fishing reel, with a spade terminal on the leading end of the wire. The Army Longwire is simply attached via the spade lug terminal to the antenna tuner's output post, and then you walk off into the woods with the reel, trailing the wire behind you. When you feel you have

reached a minimum of a ¼ wavelength from the tuner, then you can toss a line up into a high tree and attach the reel to it. Once hoisted, you have a perfect sloper antenna with very little loss.

So how does it work? The first weekend in October I was up in Cook's forest with my extended family when I broke out my trusty 20m MFJ QRP set. My MFJ folded dipole, however was safe at home, right where I left it. I was NOT a happy camper! The Army Long wire was safely tucked in the bottom of my radio bag though. YES!!

10 minutes and a couple of wry joke from various family members later, the longwire was up, and I had worked 6 California stations in the California QSO party with only my trusty MFJ QRP rig. SUCCESS!!

The Army Longwire, when used against a ground, and with a tuner is as close to a universal antenna as you are going to get. If it doesn't load up right, just shorten or lengthen it a bit. When you are done, reel it back in and stick it in your pocket.

Don't have an Army Depot in your backyard? No problem. A fly reel and 200' of flexible wire will set you back all of 15-18 bucks at K-Mart or Wal-Mart. Reel up most of the wire and put on a large ring or hook terminal to connect to the antenna tuner. That's it! You now have a true, ALL-BAND wire antenna.

I also pack a spool of 10lb. Test monofiliment fishing line and an old padlock to use in getting the antenna up into the trees.

A ground rod really helps the performance, but isn't absolutely necessary in most cases to get on the air.

Television Hill Repeater Report

We lost our position on the top of WPXI's tower for our 444.4 MHz repeater. We knew this would happen when WPXI needed to upgrade the tower to handle their new HDTV antenna. For those who didn't know we shared an antenna with WPXI, it was on top of their tower connected to 800 feet of hardline. WPXI used the antenna a couple of weeks in May, and we used it the rest of the year. Today the repeater is still located in WPXI's basement. The repeater is on-the-air using our standby antenna, located on the top of their building. There is a chance we will be able to find a spot on their tower after all of the construction is finished. If we are unable to do so, we will look for a new location.

The 147.09 MHz repeater is also located at WPXI. It's antenna is still on the tower and is not effected by the tower upgrade.

All of us are very thankful for WPXI's support. Their generosity is something I wish we could repay but there is no way for NHARC or the Pittsburgh Ham Radio Community to really express how grateful we are for their help. Thank You WPXI!

The famous licensing information pages by Veikko Komppa "Veke" OH2MCN are moving to http://www.qsl.net/oh2mcn/license.htm. The change has been done due to a policy change at VTT, The Technical Research Centre of Finland.

The above pages contain detailed information on how to get a radio amateur license when you travel abroad. The material (about 1 Mbytes) covers in practice all radio amateur countries with 230 entries at the moment. The information includes Contact information of PTT, National club, Paperwork needed, the best way to get a license, Price, Special calls, How long before you can operate, License restrictions, Customs, Useful local contacts, Places to operate from, Notes, and Travel hints. The pages are shared with the similar pages of ARRL (Operating Permit Information by Country).

The above pages have helped numerous recent DX-peditions in sorting our how to do it in practice.

ARRL Contest News: VYØ Status

The ARRL Contest Branch has been asked to clarify how **VYØ** Nunavut Territory fits into the ARRL Contest Program, in particular how it will count as a multiplier in contests.

The Nunavut territory was created in April 1999 from territories



formerly part of the Northwest Territories. It was granted a specific amateur radio call sign prefix of VYØ. Within Canada, it remains a territory, not a new province.

In contests which use ARRL/RAC sections for scoring, Nunavut remains part of the Northwest Territories / Yukon multiplier, not an addition or new multiplier. This includes the ARRL Sweepstakes and 160 Meter

Contests. In contests which use political delineations, the Nunavut Territory, which is being given the abbreviation designator of **NU**, will count as a new multiplier, effective January 1, 2000. This includes the International DX Contest, the RTTY Round-Up and the 10 Meter Contest. Field Day, which does not use sections, provinces or states as scoring multipliers, is not affected. The IARU HF World Championship uses ITU zones as multipliers and is not affected.

FCC Enforcement News

WASHINGTON, DC, Oct 27, 1999 — The Federal Communications Commission has made it official. The FCC has announced the creation of two new bureaus — the Enforcement Bureau and the Consumer Information Bureau — effective November 8. FCC Chairman Kennard made the



announcement before the House Telecommunications Subcommittee.

The FCC says the change will enhance the Commission's ability to serve the public by improving the effectiveness of the agency's enforcement program in an increasingly competitive communications marketplace. It will also maximize the ability of consumers to obtain quick, clear and consistent information about their rights under communications law.

"Our decision to establish bureaus devoted exclusively to enforcement and consumer information signals the enormous importance of these functions in our transition from an industry regulator to a market facilitator," Kennard said. "This reorganization is the first step in a larger effort to streamline and modernize the FCC."

Kennard said he looks forward to continuing to work with his colleagues at the Commission and in Congress "to implement the additional measures that will be critical to redefining ourselves as we enter the 21st Century." The new bureau will consolidate enforcement functions--including amateur--and personnel from the Commission's existing Common Carrier, Mass Media, Wireless Telecommunications and Compliance and Information Bureaus.

Current FCC Legal Adviser for Enforcement Riley Hollingsworth, K4ZDH, says he hopes the reorganization eventually will permit him to increase the amount of time he's able to devote to Amateur Radio enforcement. Hollingsworth will get a new title as part of the reorganization: Special Counsel for Amateur Radio Enforcement.

The new CIB will consolidate the FCC's Gettysburg Call Center, the Office of Public Affairs' Public Service and Reference Operations Divisions, most of the existing staff in the Wireless Telecommunications and Common Carrier Bureaus responsible for handling informal consumer complaints, and staff from other bureaus responsible for handling public information requests. The Consumer Information Bureau also will oversee the Commission's compliance with disabilities-related legal requirements.

Hollingsworth says his temporary duty as manager of the FCC National Call Center (to be renamed the Consumer Center) will be extended a few more weeks. He has agreed to be detailed back from the new Enforcement Bureau to the new Consumer Information Bureau to handle the Consumer Center at Gettysburg after the new bureaus become effective November 8. The temporary duty will last four to six weeks. Hollingsworth says Amateur Radio enforcement will be his priority, and, by agreement between the two bureaus, amateur enforcement will continue at its present pace. Hollingsworth's current duties also include Land Mobile Service enforcement.

The Commission is retaining a small stand-alone Office of Media Relations to interact with news media and oversee the agency's Web site. The Office of Public Affairs will be phased out once the reorganization is effective.
