More reservations are more coming in every day. That's good, but plenty of great tables still available (and going fast!) if you know someone who has a few things to sell (or wants to split a table with someone).

Now is the time that WASH needs everyone to do a few little things, the next few weeks, to help ensure another successful hamfest. The flyers are out, but we still need to spread the word. Visit some new repeaters, make some new friends, and mention the hamfest. Check into some of our neighboring clubs' weekly nets and do the same. If someone wants a flyer, or directions, let one of the hamfest staff know and we'll get it to them.

Don't forget to mention that we'll have free coffee to all all day, courtesy of **Ham Radio Insurance Associates**. Doesn't sound like much, does it? It was a big hit last year, so much so that other area hamfests have started to do the same thing. We want people to come, not just to browse and buy, but to sit, relax, and meet up with old friends — that's part of what being a top hamfest is all about.

And mention that **Hoagie Haven**, who served those fantastic lunches last year, will not only be back as our caterer, but will be doing breakfast, too! Can't wait!

Beyond that, let Steve & Bill know when you'll be available to help out the day of the hamfest. We have from 5 to 6 to set up tables, talk-in, and get the hall ready. We need a few hands between 6 and 8 to assist the vendors in finding their tables (and get them a cup of coffee or two, too) and run the coffee pot. From 8 on, we need you to help man the entrance, club table, parking, ticket & 50/50 sales, and generally make sure that the vendors and attendees are having a good time. It doesn't take much time for anyone if everyone pitches in.

WASHFest has earned a reputation for being one of the best WPA hamfests of the year. Let's all do our part to keep it, as Bill put it last year, a "First Class" hamfest this year and for years to come!

A Contest Blast!

The Second Annual WASH 2M FM Contest took place on Saturday evening, January 12th, with narely a hitch. A large contingent of area amateurs descended on the 2 meter band and spent 4 fun-filled hours trying to work each other.

Early indications are that most of the operators had a great time! Unlike last year, the addition of available frequencies to use and the absolute prohibition on using 146.52 and lower simplex channels avoided the problem of stepping on existing QSO's or schedules — no complaints were heard. And the expansion of bonus stations to include all "bona-fide" club stations brought some out of the woodwork, including WA3COM (WACOM), W3KWH (Steel City ARC), W3LWW (Foothills ARC), and late in the contest, W3VC (Carnegie Tech Radio Club, aka CMU ARC).

There were some dissappointments. Few if any stations from Ohio or West Virginia were worked this year, and only some of the southern most stations could work the small number of Western Maryland stations that showed up. A few mobile/portable stations did not always know what ZIP code they were in. And the N3SH club station, originally operating portable from the West End Overlook, was forced by intermod problems to relocate to the Crafton area (although this did permit them to rework many stations from the new ZIP code).

Don't forget, logs (w/SASE) are due to contest chairman Ed N3ZNI by February 7th. Certificates will be awarded to the top finishers at each power level in the Member, Non Member, and Club Station categories; and every entrant will be getting a raffle ticket to WASHFest 2002!

A QSL Manager's Dream

Tony Martin W4FOA

Due to a recent, unexplained number of problem QSLs received and a wide-ranging variety and style of QSL'ing, I would like to take the liberty to forward what I consider the QSL Manager's Dream. For the Old Timers, please bear with me and for the younger generation, please take these suggestions as only that, constructive suggestions. To the many other QSL Managers out there, if your thoughts differ, please feel free to offer them because this is not intended to say this is the only way. Please weigh in because your mileage may vary.

One QSL Manager's preferences:

1. I much prefer DIRECT QSLs. They're much easier to deal with a dozen or so cards at a time than hundreds at one time via the buro.
2. A large outside envelope with the QSL card and SASE enclosed. It is nice when the SASE (or SAE) does not have to be folded/unfolded. Also, enclosures (IRC or US Green Stamp) not folded or placed inside the return envelope. I could tell you some stories about how some of the enclosures have arrived.
3. Personally I prefer one US Green stamp over IRC (whenever possible). I THINK where US dollars are available, they are considerably less expensive than one IRC. US managers can reply worldwide for \$1 US or less. The excess (20 cents) can be used to respond to direct cards received without sufficient postage.
4. Multiple QSOs on one card where possible.
5. Fill out cards as neatly as possible. Double check the log data when placing info on cards....a big problem.
6. Use Day/Month/Year (D/M/Y) format and UTC (Zulu time). If possible abbreviate month as JAN, FEB, MAR or use Roman numerals I, II, III for month. This helps in arranging cards in proper reply order. Use 4 digit years to avoid confusion.

I'm sure I have missed something as I'm writing this "off the cuff". Please don't consider this message as a "gripe" because it is not written in that light. I enjoy helping DX stations, serving as a QSL manager. Give it a try, offer your services to a DX station, you might find it enjoyable too!

ARRL Field Day, Affiliated Club Competition Changes For 2002 Announced

NEWINGTON, CT, January 29th, 2002--The ARRL has adopted rule changes affecting Field Day and the ARRL-affiliated club competition. The changes were included in the report of the Membership Services Committee (MSC), presented to the ARRL Board of Directors at its January meeting in Fort Worth, Texas.

The primary Field Day change — effective with running of this year's event June 22nd & 23rd — phases out the Novice-Technician station and replaces it with a new station category, the "Get-On-The-Air" — GOTA — station. A GOTA station is intended for operation by Novice and Technician operators or by generally inexperienced or inactive amateurs as well as by as-yet-unlicensed or "under-licensed" operators working under the privileges of a licensed control operator. Under the revised rules, any Class A Field Day entry operating at least two transmitters may include a GOTA station, which will not count as an additional transmitter for the purpose of entry category.

The GOTA station may operate on any Field Day band and mode, but only one GOTA transmitter may be in use at any given time. The GOTA station may complete up to 400 QSOs to be counted towards the group's total Field Day score. A Field Day group can claim 100 bonus points, if its GOTA station successfully completes 400 QSOs. The GOTA station does not affect the additional VHF/UHF station provided under Field Day rule 4.1.2. Field Day 2002 will mark the first in which stations throughout the Americas have been invited to participate. As approved at the July 2001 ARRL Board of Directors' meeting, all International Amateur Radio Union Region 2 countries — North and South America — may take part in Field Day starting this June.

Complete Field Day rules and information packet will be available on the ARRL Web Contest Forms and Rules page in early February. Field Day 2002 pins and T-shirt may be ordered now via the ARRL Web catalog, found on-line at www.arrl.org.

The Board also adopted the MSC's recommendations regarding club competition. In accordance with the advice of the ARRL Contest Advisory Committee, five specific changes were approved and will go into effect November 1, 2002, when the "General Rules for All ARRL Contests" are updated for the 2002-2003 contest season. Under the revised ARRL club competition rules:

- ◆ The Board has altered the requirement that a member must attend at least two club meetings a year in order to be allowed to submit score for a club in the unlimited and medium categories. The new rules will allow participation by "a member in good standing," as defined by the club. "In part, this change recognizes that the dynamics of many clubs have changed," said ARRL Contest Branch Manager Dan Henderson, N1ND. "Many clubs hold meetings on the air and on the Internet. Many clubs have large, active participation on club e-mail reflectors." Henderson said that by allowing clubs to define their own standard for "member in good standing," clubs can include more operators as active participants in contesting activities.
- ◆ Medium and unlimited clubs now may define their club service

area *either* as a 175-mile radius circle or as an entire ARRL section. This change will allow clubs from larger states than encompass entire ARRL sections to compete with each other. Clubs may select one definition or the other but not both.

- ◆ The percentage of operators who must be members of a club in order for the club to claim a score from a multi-operator station has been reduced from 66% to 50%.
- ◆ A station owner no longer must be a member of a club in order for a guest operator at the station to claim the score for that club.
- ◆ Canadian clubs that are full Radio Amateurs of Canada affiliates now may participate in the ARRL Affiliated Clubs Competition.

Ten-Tec To Replace Omni VI with New Top-Of-The-Line ORION

I thought it might be time for some comments from Ten-Tec directly about the ORION.

Frankly, there isn't a lot to share about it as of yet, and here is all the information I have available at the moment:



ORION will be a completely new, ground-up design top-of-the-line HF transceiver from Ten-Tec. We anticipate the retail price will be in the \$3,300 range.

ORION will be a true dual receive HF transceiver. We anticipate that the receiver performance will exceed the Omni-VI Plus and all of the currently available Japanese HF transceivers.

Main receiver is amateur radio bands only, utilizing both analog and IF-DSP stages, 10-160 meters. Sub receiver is IF-DSP, general coverage. Transmitter is 100 watts output.

Cosmetics are still being finalized. The transceiver will use an LCD display screen similar to the Jupiter but larger and not the same color background display. Case color will be black.

There will be a number of new features on ORION that haven't been found on anyone else's previous rig. We can't release complete details on these until the specs are finalized.

There is no estimated delivery date, other than it will be available sometime later in 2002. We plan to introduce and show the new rig at the Charlotte Hamfest on March 9-10 and at Dayton Hamvention in May. By then, we should have feature and spec information to distribute about the new rig.

We are VERY excited about this new product. Stay tuned

SY & Mount Athos

This made me very sorry, so on September the 10th 2000 I wrote the Ministry about that, informing them that after this happening I had decided not to use the **SY2A** call-sign at all.

Since they might not be familiar with amateur radio matters, I sent them international lists where Mount Athos appears as **SY**, as well as the CEPT list. So far, I have received no answer. Despite all this, some colleagues begged me to show up as **SY2A**, and so, as a monk, I obeyed and I made happy over 6500 operators! Nevertheless, after that (end of year 2000) I stopped, waiting for some answer from the Ministry.

Unfortunately, the people working at the Ministry are not ham radios and they cannot understand the importance that Mount Athos has for the DX, being it a separate DXCC entity. Since in these months I have been asked by many friends from abroad why I do not show up, today I let you know the reason. Furthermore, I ask for your help. You can send a message to the Ministry (E-mail: yme@otenet.gr) and ask them to stop issuing the **SY** as a special prefix, since it has belonged to Mount Athos for the last 30 years, as international lists and maps show.

Furthermore, seizing the opportunity, you could ask that **SY** will be permanently assigned to Mount Athos, as it is reported also on the 'CEPT' list, so that confusion will come to an end, once for all. Placing my trust in God, I wait for the solution of the problem, and then I will be with you again... as much as my monastic duties and all the difficulties here will allow it to me. From Mount Athos, "the Garden of the Virgin Mary", I send all of you my best wishes for a peaceful 2002!!!

DX News Briefs



VP8THU from the South Sandwich island group was the big news of the month, as they were only QRV on Thule Island from about January 18th to 24th. After a few days travel on the ship Braveheart, they went QRV on South Georgia as **VP8GEO** on January 27th. They are expected to be there through the first week in February. Most DX'ers report large pileups and difficulty hearing the signals, as they Dxpediton is running 100 watts and wire antennas due to the severe restrictions of their landing permits. **VP8THU** should be QSL'd **VE3XN**. **VP8GEO** is via **VE3GCO**. Astute observers note that both calls are using the same address (**VE3XN** is the trustee for the **VE3GCO** club), but the two different names are being used to keep the envelopes for the two stations separated. **VE3XN** is planning to handle first the **VP8THU** cards, then the **VP8GEO** cards; only then will cards for both that are sent together in the same envelope, so it's not a good idea to try & save a stamp if you work both! — **VE3XN, JA3AAW, VP8THU, VP8GEO, OPDX, W3UR, AD1C**

FCC News

NEWINGTON, CT, January 21st, 2002 — The FCC has reduced a sanction imposed last year against a California amateur who had been banned from using repeaters on the 144, 222, or 440-MHz bands for three years. The case involved allegations that Ted R. Sorensen III, KC6PQW, of Agoura Hills, California, and Gregory S. Cook, ex-KC6USO, of Chico, California, had conspired in making late-night one-way transmissions on the W6NUT 147.435 MHz repeater that originated from Sorensen's station. The transmission included music and commentaries on many of the songs, the FCC has alleged.

Last March the FCC accepted Cook's voluntarily surrendered license. Although he did not dispute the allegations, Sorensen got a lawyer and protested his lengthy banishment. In his initial response to the FCC, Sorensen offered to accept a suspension from talking on the W6NUT repeater for a year "as fair punishment." After reviewing Sorensen's case, the FCC decided to accept that less-stringent settlement of the case, rather than get involved in a hearing.

"We will accept Sorensen's settlement of this matter, which is a prohibition from operating on the W6NUT repeater for one year," FCC Special Counsel Riley Hollingsworth said December 20th in a letter to Sorensen's counsel, George L. Lyon of Washington, DC. "Inasmuch as he ceased operation on the repeater for two and a half months, this prohibition against operating on the W6NUT repeater will begin at midnight December 31, 2001 and expire automatically at midnight September 15, 2002."

In modifying Sorensen's license last year, Hollingsworth had invoked §97.27 of the FCC's Amateur Service rules. Sorensen had been the subject of prior repeater-related enforcement inquiries.

Not long after the February 2001 one-way transmissions attributed to Sorensen and Cook, the FCC launched a review into the operation of the W6NUT repeater. That investigation continues. Hollingsworth said the FCC gets more complaints about the W6NUT repeater than any other repeater in the US. Hollingsworth has informed the repeater's trustee, Extra licensee Kathryn Tucker, AA6TK, of La Mirada, of complaints that control operators and the repeater licensee "fail to address long periods of jamming by users, broadcasting, music playing as well as a plethora of other violations."

The FCC has fined a Texas man \$10,000 for transmitting without a license on an Amateur Radio band. Following a *Notice of Apparent Liability* issued in September, the FCC affirmed the \$10,000 fine in a December 26th *Forfeiture Order* to David Edwin Merrell of Wichita Falls. The FCC said Merrell did not respond to the *NAL*.

In its earlier *NAL*, the FCC said it was acting on "numerous complaints" from the amateur community that an unidentified station operating on 7235 and 7238 kHz in the 40-meter band was causing "intentional interference to authorized communications." The FCC's High Frequency Direction Finding network determined that the signal was located in the Wichita Falls area. Last June, agents in the FCC's Dallas office monitored an unidentified station on 7220 kHz and determined that the transmission was coming from Merrell's residence. "The station did not identify and transmitted only one-way broadcasts," the FCC said.

During station inspection, Merrell "admitted to the transmissions and stated that he did not have a station operator license," the FCC said. Merrell reportedly told the FCC agents that making the transmissions was "something to do" and were made "to get attention," the FCC said. The FCC said Merrell stated he was not interested in talking to people but only in making one-way transmissions.

Unconfirmed reports to the FCC indicate that Merrell may have

continued to occasionally transmit on 40 meters following the visit by FCC agents to his residence.

The FCC said that based on the evidence, Merrell "repeatedly and willfully" violated Section 301 of the Communications Act by transmitting without a license. "Considering the entire record and applying the statutory factors listed above, this case warrants a \$10,000 forfeiture," the FCC concluded.

Merrell has 30 days from the date of the *Order's* release to pay the fine. If not paid, the matter could be referred to the Department of Justice for collection.

Former Amateur Radio licensee Herb Schoenbohm, ex-KV4FZ, apparently is eager to return to his favorite pastime. In early January, the FCC suggested that Schoenbohm, who lives in Kingshill, Virgin Islands, won't get his wish easily. Last April, only a few months after losing his battle to renew his ham ticket and his operating authority had expired, Schoenbohm applied for a new Amateur Radio license and passed the General exam. The FCC now has designated that pending application for hearing, to determine, in part, if Schoenbohm is rehabilitated and deserves to be a Commission licensee.

The FCC didn't mince words in its *Hearing Designation Order*, WT Docket No 01-352. Schoenbohm's "previous criminal behavior, misrepresentation and lack of candor warranted denial of his renewal application," the *Order* said. "Mr. Schoenbohm is a convicted felon and was found to have misrepresented facts and lacked candor in his testimony in that hearing."

The FCC said, however, that what's past is past, and it does not intend to rehash Schoenbohm's earlier case in the current proceeding. Now, the Commission says, it must determine whether Schoenbohm "has been sufficiently rehabilitated" since his earlier "disqualifying behavior." The Commission said it needs to know if Schoenbohm "could be relied upon to observe our rules and policies and deal with the Commission in an honest and forthright manner."

The FCC said that since it has "no facts now before us that would support a finding of rehabilitation," it cannot make a ready determination that granting Schoenbohm's application "would serve the public interest, convenience, and necessity." So, it's designating his application for hearing.

"Absent a demonstration by Mr. Schoenbohm that he now possesses the requisite character qualifications to be a Commission licensee, his pending applications may not be granted," the FCC added. Schoenbohm vowed last year to return to Amateur Radio.

Meanwhile, the FCC is continuing to investigate whether a South Carolina amateur broke any rules when he let Schoenbohm operate during a recent contest. Stephen S. Reichlyn, AA4V, rented and operated from Schoenbohm's station during the CQ World Wide SSB Contest last October. Reichlyn confirmed that he had asked Schoenbohm to fill in briefly as an operator on two occasions. He said he fully supervised Schoenbohm's operation, but conceded in his response to the FCC that he may have exercised poor judgment in asking Schoenbohm to operate.

The FCC said Schoenbohm would bear the burden of proof in the new license application proceeding before an administrative law judge to determine whether he now possesses the requisite character qualifications to be a Commission licensee and whether his pending application should be granted. Schoenbohm has 20 days to respond to the *Order* or his application will be denied with prejudice.
