Pa QSO Party 2018: K3HCR Cambria County

Chartiers Township, PA, October 13th, 2018 --Well if nothing else, we're consistent. This year Harold K3HCR, Larry K3VX, Mike WA3PYU and Bill W3WH operated the Party from Prince Galitzin State Park

in Cambria County. Why are we consistent? Because we missed a Clean Sweep by 3 counties AGAIN! Grrrrr. Cameron, Bradford and Snyder did not make it into our log. On the other hand missing three counties didn't ruin the weekend at all. We gave it a good effort and had a good time.

The cabin we rented was comfortable and warm; we had plenty to eat and drink, but amazingly only consumed 4 beers the whole weekend. That's probably a new record low!

We had very limited space for antennas. Larry found a fan dipole design which used PVC tubing to separate the feed points of an 80 ,40 and 20 meter dipole by 5 ½ inches at the feed point, and 19 inches at the respective ends. In conjunction with the Club's new diplexer and bandpass filters, there was no interference on adjacent bands. Wow what luxury!

We also deployed a second fan dipole (Alpha Delta DX-CC) which also worked well. At times we were able to run two stations on the same band, using the diplexers and filters but for some strange reason not all of the time. The antennas were about 70 feet in the air, and were oriented about 90

degrees from each other. There might be some Field Day lessons here.

We used Larry's ICOM 7300 and Bill's ICOM 756 Pro. Both worked well. Also we used N3FJP to log our Q's. One thing we didn't accomplish was linking our computers but that didn't really cause any terrible problem.

It was such a treat to have Mike WA3PYU join us this year for Saturday night and Sunday. The rest of us arrived Friday around lunch time, and we finally left for home around 4:30 on Sunday. In addition to operating the Party, we worked a little DX, Based a lot and just generally enjoyed the chance to OD on Ham Radio..

We really would encourage others to get a group together and operate the Party whether it's from home or somewhere else. If a group won't work for you get on from home and HAVE SOME FUN WITH HAM RADIO.

Newington, CT, October 20th, 2018 – In a letter to ARRL President Rick Roderick K5UR on Friday, October 19th, Dwayne Allen WY7FD resigned as Director of the Rocky Mountain Division due to time constraints and competing duties with work and family. As such, the Secretary of the Corporation has declared the position vacant.

In accordance with Article 7 of the Articles of Association, Vice Director Jeff Ryan KØRM, will assume the Director position immediately.

Newington, CT, October 11th, 2018 – The International Amateur Radio Union Monitoring Service (IARUMS) reports interference on 40 meters from various Russian sources. The Russian coastal over-the-horizon (OTH) radar "Sunflower" was very active on 40 meters and audible in Europe in the evenings, transmitting FM on pulse. The site is believed to be northeast of Vladivostok. IARUMS Region 1 Coordinator Wolf Hadel DK2OM, said it was monitored in September.

In addition, a Russian ship was observed transmitting on 7110 kHz on F1B with 50 baud and 200 Hz shift. The vessel was believed to be in the area around and east of Cyprus, on the air daily in September running F1B with 50 baud and 200 Hz shift. Another Russian ship was heard on September 18th transmitting AT3004D with 12 × 120 baud PSK2A on 7179 kHz with a 2.6 kHz bandwidth in the area of Crete.

And a Russian military system, believed to be near Moscow, was heard transmitting on 7198 kHz in AT3004D test mode.

Elsewhere fishing crews often were monitored on 3500, 3535, 3540, 3560, 3585, 3590 & 7000 kHz, and 14.320 MHz USB.

Pa QSO Party 2018: N3ZK Warren Count

Imperial, PA, October 3rd, 2018 - I know I have been "MIA" at meetings but please know that I do wish to attend except that working for a west-coast company - they have meetings that run over dinner time here on the east coast and I can't make it to the meetings unless they cancel one.

I want to thank the general membership for allowing the use of the tower-trailer. I have worked closely with Bill W3WH for several days to ensure that my insurance liability of the trailer falls squarely on the users and that ample coverage from a transportation perspective was well covered. I myself, am in the nuclear business and we wake up each day focusing on Safety first, second, and third.

Background:

Each year, the N3ZK contest team operates the PA QSO party and with superb results except for west coast contacts that could account for as many as 12-15 ARRL sections - which in the PA QSO contest counts as multipliers to a total score, not just points. This year, myself, Frank and Jim and Randy will be putting forth our best efforts to clean sweep and crush the existing record.

Engineering:

After some previous years' post-contest antenna simulations led by Jim, WB4GCS and Frank, N3FB it was asserted that we needed to get our 20M beam up higher than what we could install safely - this is where the tower trailer can come in quite handy. We hope to snag those elusive West-coast stations nicely with the advance height that the trailer offers.

A call to action:

This year, we chose to operate out of warren (WAR) county and hope to hear every WASH club member helping us add to the overall score – we are typically loud on 20, 40, 80, and 160m thanks to the engineering efforts of Frank, N3FB in his antenna and RF choke designs.

Behind the scenes:

To give you all an idea about the effort we put in, the 3-4 of us put up 8-9 antennas, run 1500+' of coax, run 4-5 radios with minimal interference, feed ourselves in sometimes austere environments (and lots of coffee) - and yet our goal remains to get a clean sweep of all 67 counties and crush the previous county record with persistence each year - admittedly, we return home exhausted each year – but EXSTATIC for the experience. So far, the N3ZK team has claimed at least 5 or 6 county records in WPA

In closing:

I encourage you all to get on the air and operate from your home stations and find out what makes the PA QSO party different than all the rest. FYI: there are several programs out there designed specifically for this contest like N1MM & N3FJP.





I counted around 13 elements on one boom, so if they're doubled, a 26 element log-periodic? It was absolutely huge. Tower was just as impressive.


I'm guesstimating AT LEAST a 30' boom.....

FAA Overhauls Tower Marking Requirements American Radio Relay League



In the wake of fatal crop-dusting aircraft collisions with METs, the National Transportation Safety Board (NTSB) had recommended that states institute laws, sometimes called "crop duster" statutes, requiring marking and registration of METs. While some state crop-duster laws exempted ham radio towers, federal regulations dating to the 1996 FAA Reauthorization Act did not, and ARRL had expressed its concerns since.

"There is no evidence whatsoever that even one Amateur Radio antenna below 200 feet has ever been involved in an aviation accident," ARRL General Counsel Chris Imlay W3KD, said. "To impose painting and lighting requirements on Amateur Radio antennas between 50 and 200 feet tall would preclude many, if not most, of the exurban, rural, and, in some cases, suburban Amateur Radio antennas that are and will be sited outside incorporated towns and cities. This would ironically defeat the entire reason such antenna facilities are sited in those environments: because rural and exurban areas are where such antennas are permitted and the few areas where antennas are not precluded entirely by private land use regulations."



Prior to 2017, per long-established FAA regulations, unless such short radio towers were located within the glide slope of airports or heliports, they were not required to be painted or lighted.

After attempting to address the issue through the FAA, ARRL's legislative team met with staff members of Senator Jim Inhofe (R-OK) and other lawmakers and their staffs associated with the congressional committees of jurisdiction. Senator Inhofe — himself a pilot — was of the view that the 2016 legislation was excessive and that exemptions should exist for both broadcast and Amateur Radio antennas and support structures. "We worked with our close allies at the National Association of Broadcasters (NAB), [who were] afraid that this legislation would have a large adverse effect on short broadcast towers," Imlay recounted. "We also worked with the Association of American Railroads, which has hundreds of short towers along rail lines in rural areas that would have been affected."

Imlay said Section 576 of the large 2018 FAA reauthorization now requires that the only towers less than 200 feet tall that have to be painted and lighted are meteorological aids and those within the glide slope of an airport or heliport. The remainder of such towers in rural or agricultural areas lower than 200 feet need to only be included in an FAA-maintained database, which will be updated by the owners of such towers.

Imlay credited members of the ARRL Legislative Advocacy team, as well as Senator Inhofe and ARRL's broadcast and land mobile association partners for getting the language revised in the new, 5-year Reauthorization Act. "We consider this a big success for Amateur Radio," Imlay said, "and it would not have been possible but for the visibility that has been achieved for ARRL through our active Capitol Hill advocacy for the Amateur Radio Parity Act."

Major Changes to ARES and OO Programs

The ARRL Public Servie Enhancement Working Group has completed its two-year project to re-tool the Amateur Radio Emergency Service (ARES) to meet the requirements of partner agencies, nationwide. The new program will consist of ARES Members who are "organized, trained, qualified and credentialed" to better serve our partner agencies.

The new program features three levels of ARES membership, which are matched by three levels of required training and certification. The training requirements will be met by members completing free, online courses including NIMS IS-100, IS-200, IS-700 and IS-800 and the newly revised ARRL EC-001, which will be provided free of charge to ARES members. Additional training is required for all ARES leadership appointees ("*ECs").

The ARRL Board has opened a public comment period which runs until October 31. ARRL requests your comments to be sent through your Section Emergency Coordinator <<u>sec@wpa-arrl.org</u>> and Section Manager <<u>sm@wpa-arrl.org</u>> only. The Board will review all comments and vote on the final program at the January 2019 ARRL Board Meeting.

The current OO program will end, and be replaced by a new Volunteer Monitoring program, administered by ARRL HQ, working closely with FCC.

All current OOs will be invited to apply for the new program, which will concentrate on major enforcement issues the FCC requests. The goal is to provide more rapid enforcement response to significant, developing on-the-air violations rather than more minor operating and technical issues.



DX News Briefs

The VP6D Ducie Island Dxpedition is in its last few days we are going to deadline. They have passed 110,000 QSOs, according to their "DXA" near-real-time monitoring page. The operators have asked that stations monitor the DXA page when trying to work



every minute, but there can be a lag of up to 3 or 4 minutes between the time a station is worked, and it shows up on the screen. The page can be found at http://www.dxa3.org/vp6d/. While it also can display which bands/modes a station has been worked on, some CW contacts are not appearing in the DXA, but are appearing in the online log at https://vp6d.com/index.php/ logsearch-ogrs. Indications are that VP6D will begin dismantling after local sunrise on November 1st, starting with the CW stations and CW camp. They expect to be QRT by sometime midday, and off the island by November 3rd QSL via OQRS, which will be active after the end of the Dxpedition.

News reports indicate that recent attempts to get permission to operate from KH7K Kure Atoll have failed, due to concerns from the Hawaiian Department of Land & Natural Resources. The story from the organizers of the latest attempts can be found on Pages 13 & 14 of this newsletter.

LA7GIA's operation as TT8KO was shut down by the national security police on 10 October, after only 2 days QRV. While he was not detained, he was not permitted to leave the country (or operate) for two weeks; he was finally granted permission to leave on 25 October. News reports he has arrived home safely. W3WH, K3VX, WO3Z and K3GW will be operating as VP9I in the 2018 ARRL 160 Meter test. Outside of the contest, they will operate as Home Call / VP9, approximately 29 November – 2 December. QSL VP9I via Logbook of the World, others as indicated. - W3WH

Newington, CT, October 3rd -- ARRL has taken a minor exception to the wording of a September 24th FCC Enforcement Advisory pertaining to the importation, marketing and sale of VHF and UHF transceivers and is in discussion with FCC personnel to resolve the matter. The Enforcement Advisory was in response to the importation into the US of certain radio products that are not FCC certified for use in any radio service, but identified as Amateur Radio equipment.

"While much of this equipment is actually usable on Amateur bands, the radios are also capable of operation on non-amateur frequencies allocated to radio services that require the use of equipment that has been FCC-certified." ARRL said. "Such equipment is being marketed principally to the general public via mass e-marketers and not to Amateur Radio licensees.'

ARRL said the upshot is that the general public has been purchasing these radios in large quantities, and they are being used on the air by unlicensed individuals.

"Radio amateurs have complained of increased, unlicensed use of amateur allocations by people who are clearly unlicensed and unfamiliar with Amateur radio operating protocols," ARRL said. But while it supports the general tenor and intent of the Enforcement Advisory, ARRL said it disagrees with the FCC on one point

"In several places, the Enforcement Advisory makes the point that 'anyone importing, advertising or selling such noncompliant devices should stop immediately, and anyone owning such devices should not use them," ARRL pointed out. "The Advisory broadly prohibits the 'use' of such radios, but our view is that there is no such prohibition relative to licensed Amateur Radio use entirely within a mateur allocations — of a radio that may be capable of operation in non-amateur spectrum, as long as it is not actually used to transmit in nonamateur spectrum.

ARRL has had extensive discussions about this issue with FCC Wireless Bureau and Enforcement Bureau staff, and those discussions are ongoing.

"It is important to protect the flexibility of the Amateur Service as essentially an experimental radio service, but it is also very important to stop the unlawful importation and marketing of illegal radios in the United States and the use of those radios by unlicensed persons," ARRL maintained. "We will keep our members informed as our discussions with FCC on this subject continue."

Hawaii DLNR Denies Amateur Access to Kure Atoll

Trivoli, IL, October 13th, 2018 - Over the course of the past four years, the Pacific Islands DXpedition Group (PIDXG) has sought permission to conduct a DXpedition from Kure Atoll, currently ranked by ClubLog as the #7 Most Wanted DXCC entity. During this time PIDXG has filed four separate permit applications. Due to scheduling conflicts, the first application filed in November 2014, was voluntarily withdrawn in April 2015 following authorization by The Nature Conservancy for the PIDXG's January 2016 K5P Palmyra Atoll DXpedition.

A second permit application, filed in April 2016, was also subsequently withdrawn, nearly one-year later, due to the ARRL DXCC action deleting Kure Island (and Midway Island) from the DXCC program. However, following its DXCC reinstatement, a third PIDXG permit application for Kure was filed in July 2017

During the process of these three permit attempts, several email exchanges occurred to address the reviewing agencies follow-up questions and legitimate concerns about our activity coinciding with Kure Atoll's albatross season.

Ultimately, our third permit application stalled out. Email status requests went unanswered. In December 2017, a phone call was placed to our Permit Coordinator assigned from Hawaii's Division of Forestry and Wildlife and we were advised that an official denial package would be returned to PIDXG following a January 2018 Trustee Review Board meeting in Honolulu.

After many email requests and phone calls on the status of the denial, on June 25th, 2018 PIDXG finally received the formal denial package from the Chairperson of Hawaii's Department of Land and Natural Resources (DLNR). The official position was that amateur radio cannot be conducted with adequate safeguards for the resources and ecological integrity of Kure Atoll. They contend that our use of antennas would pose a considerable risk to the island's bird population in spite of the fact that we indicated in our application we would be following USF&W approved guidelines and protocols successfully used by DXpeditions in other National Wildlife Refuges (NWR) and as praised by USF&W officials. Follow-up phone calls and emails to Hawaii DLNR officials requesting additional clarification have been ignored and a formal Freedom of Information request to the State of Hawaii has likewise resulted in no substantive information relative to the denial.

Throughout each attempt of the permitting process, PIDXG has acted in good faith in its efforts. It has adhered to all procedural and application guidelines

necessary for requesting access to this Public Land, land where amateur radio has already been determined to have existing use by the same Federal agencies overseeing this and other Pacific NWRs.

It is the understanding of PIDXG that there have been NO documented instances of negative impact to the ecological integrity at any NWR from any previous amateur radio activity. Thankfully,

through the guidance of the oversight agencies and the protocols directing radio operations from these environmentally sensitive areas, it can be said that amateur radio has maintained an impeccable track record in this regard. To suggest that amateur radio poses unacceptable risks or has the potential to adversely impact seabirds and other protected species at Kure Atoll is disingenuous and without basis in fact. Again, we refer to the praises sung by U.S. Fish and Wildlife in the above-mentioned YouTube video excerpt.

The last amateur radio activity to Kure Atoll was in 2005. PIDXG does not think it is unreasonable to request the use of a U.S. Public Land for an amateur radio activity following a 13-15 year lapse.

For the record, there is no appeal process in this matter. PIDXG has requested personal meetings with review agency members to discuss this activity but no response has been given to our requests. However, the cover letter accompanying the denial package indicates PIDXG is not precluded from submitting applications in the future and will be evaluated pursuant to the findings criteria. As such, a fourth Kure Atoll permit application was filed by PIDXG on August 6th, 2018.

At this time, PIDXG requests interested DXers to help in this matter. We simply ask that you send your QSL card and brief note <u>respectfully</u> asking the Hawaii's Department of Land and Natural Resource to please reconsider their position in this matter to:







