## One Of Those Special QSO's

I was tuning a fairly quiet 40 meters one night and heard a station in Napa. CA just finishing up. I put it in park and listened as I tended to other shack things. They were saying their 73's and the Napa station signed...it was an old friend from my Alaska days, Howard AL7GS.

I couldn't believe it! Its been about 25 years since I last heard from him and his wife, Barb. He left Alaska after I did and simply disappeared. Turns out, that's exactly what they all thought I did too.

Howard was a great resource of antenna wisdom and would give my broke, car-less posterior a ride to club meetings, Field Day events, etc when I was just a newbie teenager with dreamy eyes set on one day having a huge contest farm. He would let me stop by his QTH whenever i wanted to log a few contacts. He even unlocked the door when times got tough for me and I was at the lowest points in my life (I was literally homeless and strung out) he never questioned my intentions, ever, which was good because no matter how far down in the dumps I got. I never entertained the thought of doing anything disrespectful. It was just nice to see someone who wasn't locking their car door when i walked by, or pulling their kids close. He just told me i looked like crap, but he let me warm up a bit and log a few contacts. I never knew until then just how much those little things



Howard is also one of those brilliant "antenna gurus;" we all know at least one. He once built a simple, manually turnable Delta Loop for me. It was one of the best antennas I've ever owned. Sure, if I wanted to turn broadside to EU or AF, I had to go outside to the back porch, untie the anchor wire, grab the handle and turn the 70' tall monster by hand, retie the wire in the new position and go back inside... usually in the middle of a cold, windy Alaskan night... but it was more than worth it. I logged all sorts of great stuff with that loop. I was looking through some old notebooks the other day (I never throw away old notebooks), and found the handwritten diagram for the loop that he left with me.

Turns out he had been off the air for a while, is now living amongst the beautiful orchards in wine country and working as a caregiver for older folks; a noble occupation. I don't think I ever thought to say thank you for the antenna and felt bad about that all these years. That night, I finally got to say it.

I have had many great conversations over the years with many interesting people. I've had lots of great battles in pileups, successes and failures in this great hobby. These kinds of contacts remind me that we get older, we die. There are lots of old friends I've met through the years on the air and in person that are no longer with us. I will never get to run contests with them, tell bad jokes and drink into the night with them or simply enjoy their company again. These moments never get a second chance. ## 150th Anniversary of the Transcontinental **Telegraph** Greg Beat W9GB, courtesy of <u>www.qrz.com</u>



On June 16th, 1860, about ten weeks after the Pony Express began operations, the United States Congress authorized a bill instructing the Secretary of the Treasury to subsidize the building of a transcontinental telegraph line to connect the Missouri River and the Pacific Coast.

The passage of this US Congressional bill resulted in the incorporation of the Overland Telegraph Company of California and the Pacific Telegraph Company of Nebraska.

On July 4<sup>th</sup>, 1861, Edward Creighton began building the Nebraska company's line westward from Julesburg, Colorado, toward Salt Lake City.

Twelve hundred miles to the west on the same day at Fort Churchill in Nevada, James Gamble set the first pole in the Overland Telegraph Company's line.

While the lines were under construction the Pony Express operated as usual. Letters and newspapers were carried

On October 20th, 1861, Edward Creighton won the race to Salt Lake City. Four days later James Gamble's crew arrived.

On October 26th the wires were joined, and San Francisco was in direct contact with New York City — completing the US transcontinental telegraph line.

On that same day, the Pony Express was officially terminated, but it was not until November that the last letters completed their journey over the route.

the entire length of the line from St. Joseph, MO to Sacramento, CA — but telegrams were carried only between the rapidly advancing wire ends.

## Chevy Turns to Ham for Antenna Solution

Camaro Convertible is On His Wavelength

General Motors News Release

Detroit, MI, December 17th, 2010 - When spy shots surfaced of the pre-production version of the 2011 Chevrolet Camaro Convertible, an outcry went up among Camaro enthusiasts over the AM/FM whip antenna positioned on the rear deck lid.

Quite simply, they hated it.

Chevrolet was quick to respond, commissioning a self-described antenna freak named Don Hibbard W8DBH to find a way to fix it. "Antennas are a beautiful thing to me," says Hibbard, an antenna test performance engineer.

Engineers working on Camaro are passionate to drive perfection into every aspect of the vehicle. Hibbard and colleague Gregg Kittinger had to do what some thought was impossible: conceal the AM/FM antenna without sacrificing radio reception, while not putting it inside the Camaro's windows. The two, who share three other patents, happily accepted the challenge.

"We weren't sure that it would be possible," said Kittinger. "Typically antennas are hidden in a vehicle's rear window, but with a retractable soft-top roof, that's not an option."

So they came up with a novel approach - hide the antenna inside the rear spoiler. No one had tried that on a Chevrolet before because of the hit to radio reception.

"We responded to a legitimate criticism from devoted Chevrolet Camaro enthusiasts and in 10 months found an innovative way to improve the overall aesthetics of the vehicle without sacrificing performance and quality," said Kittinger.

While the shark fin antenna that transmits XM Satellite Radio, OnStar and cellular signals is still present on the car's deck lid, the built-in spoiler antenna eliminates the need for a longer, separate whip antenna to receive AM and FM radio signals.

Hibbard, a lifelong Ham radio enthusiast, says the unorthodox placement of the antenna within the body of the vehicle created a number of technical challenges, such as balancing form by preserving the car's styling and function of unimpeded audio reception.

"Where other automakers have tried and failed, Chevy succeeded," said Hibbard. "We hope to take what we've learned with the Camaro Convertible, build on it and apply it to future vehicles."



For 30 years, I rarely thought about Amateur Radio. I loved it as a teenager in Virginia, but when I grew up and left my parents' house, I left my ham days behind.

Fortunately, I did remember to renew my General class ticket every 10 years. In early 2003, I realized that I needed to update the address on my license. I filled out the appropriate form with my western Colorado address and sent it to the FCC.

A few weeks later the phone rang.

"Hi, is this Christine?"

"Yes." I didn't recognize the voice.

"This is Larry Gerbaz from the Ski Country Amateur Radio Club. Hey, you're WB4PVQ, aren't you? Do you get on the air?"

No, I said, but my father, Doug Burke WA4LKX, had given me a receiver and I had been listening to code practice on W1AW. I didn't admit it right away but I was beginning to miss ham radio.

### Search and Reactivate

Larry KØCL, went on to explain that he occasionally searches online call sign databases to learn whether any hams have moved into our area. He bubbled over with enthusiasm for ham radio. He told me about the radio club and its 2 meter repeaters. As a UPS driver for many years, Larry recognized my address.

"You're right next to that farm, aren't you? That's a good location! You should put an antenna up. You can work some DX. It's fun. Why, just the other morning on forty meters...'

I was intrigued. Perhaps I could actually get on the air again. And so began my re-entry into Amateur Radio. Along the way, I've been encouraged and mentored not only by Larry but also by my dad, my high school friend Russ Hummel, WB4PGT, and many others.

At first, the thought of getting back on the air was tempting, but daunting. That's where the Elmers came in handy. I would never have guessed how much good used equipment is available at low cost, or even for free. I didn't think I had the skills or knowledge to refurbish an old tri-bander, but guess what — it was fun. By the fall of 2004, Larry and my husband Mike were installing the tri-bander on top of our new, used 70 foot tower.

According to the Amateur's Code, the radio amateur offers encouragement and support to other amateurs. Without that encouragement, it would never have occurred to me to get my Extra class license or to work 100 DXCC entities. It's been exciting to break through the "I can't" barrier and accomplish those goals.

As the recipient of so much good help, the next challenge was for me to begin sharing my newly gained knowledge. Occasionally, I have a few of my own tips and tricks to offer, even to the more experienced hams.

On the air, I often meet others who have recently become active again for various reasons. Some have retired and have more free time. Some have moved to new homes with more space for antennas.

Admittedly, these folks are not the youngsters who will ultimately carry our hobby into the future. Nevertheless, I believe that the ranks of inactive hams have a lot of potential to increase participation in Amateur Radio. Just imagine how many more nephews, nieces and grandchildren will be exposed to the adventure of ham radio if their family members get on the air.

### Club Project

Your club can locate inactive hams and encourage them to get back on the air. If you are a bold evangelist, like Larry, you can make phone calls. If you see a tower in someone's back yard, you might even knock on the door. During his UPS days (he is now retired), Larry Continued on Page 8

The ARRL's DXCC program requires that you have a QSL (contact confirmation) card in hand for each contact. Also accepted is the ARRL computer logging system (Logbook of the World) as verification. Waiting for the confirmation cards from around the world, can take over a year, so the WACOM 100 program will require submission of your signed computer log file for verification. That is all, and that is EASY.

The start date will be January 1<sup>st</sup> and **ending on June 15<sup>TH</sup>**, prior to Field Day, with ceremony & prizes on FD). Logs must be RECEIVED by June 20<sup>th</sup> at NY9H@arrl.net, with a notation with the category in which you wish to participate. Logs may be submitted by mail or other alternative means. Categories:

- A. Amateur licensed 5 years or less reaching 100 countries first
- B. Amateur licensed 5 years or less with the most countries
- C. OT (more than 5 years) reaching 100 countries first
- D. OT (more than 5 years) with the most countries

took note of local ham towers and sometimes used his break time to go and introduce himself. If you're more reserved, you can build a mailing list. Our club mails out notices and invitations for meetings, parties and especially for Field Day. For Field Day 2009, we sent letters to a list of 80 nonmembers of the Ski Country Amateur Radio Club, based on ZIP codes within a 50 mile radius of Glenwood Springs, Colorado. A few of the letters came back with bad addresses but most reached their destinations.

The club's GOTA (Get on the Air) and VHF stations provided a great attraction for both newcomers and inactive old-timers. His wife, Debbie, was so impressed that she began studying for her Technician license. She is now KDØIRH.

### **Finding Local Hams**

There are several online resources you can use to find hams in your area. First is the ARRL's FCC search page. Enter a city and state, click SUBMIT and the results will display a list of call signs for that area. Alternatively, you can search by ZIP code, but keep in mind that some towns have additional ZIP codes for post office boxes. If you omit those, you might miss a few results

Be aware that some hams may have moved without updating their licenses. Others might be Silent Keys. The database may not contain those changes.

#### **DXØDX POSTPONEMENT**

"To the DX Community at large – It's with regret that as Team Leader, I have to announce the postponement of the DXØDX Spratly Islands DXpedition 2011, due to circumstances beyond the control of the DXØDX



Our situation began when our original mode of transport by ship was terminally damaged back in late October 2010. We then went to our contingency plan which was to fly in, as there were no ships deemed to be safe and provided facilities for safe passage to Pag-Asa, available.

We had landing permission and booked the correct sized aircraft and with the security cleared pilots. To simplify it, there was conflicting agreements and hence the aircraft could not get approval of its flight plan.

The bottom line is this. We have a license, we have authority to land via ship, hence when the ship becomes available in the near future, it is my intention to activate this entity in 2011.

The team has worked tirelessly to remove the hurdles that were placed before the them in the last minute. As time was running out for this window of opportunity, and before more operators become stuck here in Palawan, the decision was made to postpone the activation.



## **FCC News**

Newington, CT, January 6<sup>th</sup>, 2011 — In October 2010, an agent from the FCC's Enforcement Office visited Monroe, Michigan-based Doctor Radio's CB Shop to find that the store was selling, among other items, a radio that was described as "an Amateur Radio that could operate on CB frequencies" that was modified to operate above the approved power limits. As such, the FCC issued a Citation to

the store on January 4<sup>th</sup> for marketing unauthorized radio frequency devices in the United States in violation of Section 302(b) of the Communications Act and Section 2.803(a)(1) of the Commission's rules.

The equipment in question includes a Cobra 150 GTL DX. A store employee explained to an FCC agent that the

transceiver had been modified to generate 170 W of power. The store employee further explained that the Cobra 150 GTL DX was an Amateur Radio transceiver that could operate on CB frequencies. If legally operated, the 150 GTL DX operates from 28-29.7 MHz; the CB frequencies are 26.965-27.405 MHz. Section 95.655(a) of the FCC rules prohibit radios that can transmit on both the amateur and CB bands. According to the Citation, the Cobra 150 GTL DX "offered for sale at Doctor Radio had both CB and Amateur Radio capability and therefore cannot be sold in the United States."

The FCC advised Doctor Radio's CB Shop that if after receipt of the Citation, it violates the Communications Act or the Rules by continuing these sorts of sales, the FCC may impose monetary forfeitures of up to \$16,000 for each such violation or each day of a continuing violation, and up to \$112,500 for any single act or failure to act. In addition, violations of the Communications Act or the Rules can result in seizure of equipment through in rem forfeiture actions as well as criminal sanctions, including imprisonment.

Doctor Radio's CB Shop has until February 4<sup>th</sup> to respond to the Citation, either through a personal interview at the FCC's Farmington Hills, Michigan office, or via a written statement.

The ARRL has filed a complaint with the Federal Communications Commission documenting ongoing harmful interference and egregious rules violations by Broadband over Power Lines (BPL) systems installed by IBEC, Inc. in Virginia, Pennsylvania, and Indiana. The ARRL has requested that the FCC "initiate immediately an enforcement proceeding regarding these BPL systems, and cause them to cease operation until such time as they are each in full compliance with the Commission's Rules.'

Contrary to earlier representations to the ARRL and to statements in the online BPL database, IBEC's systems in these locations are not universally notching the Amateur bands as is necessary in order to avoid emissions at levels that are likely to cause harmful interference to licensed Amateur Radio stations. In fact, measurements by ARRL staff and confirmed independently show that IBEC systems are not even notching the aeronautical bands that the FCC rules require BPL systems to avoid and are operating at power levels that cause radiation well in excess of the FCC limits.

The ARRL even discovered IBEC BPL systems in operation that are not listed in the online BPL database - another clear violation of the FCC rules, which require listing 30 days prior to initiation of service.

"While IBEC was cooperative in the early stages of their BPL system development and appeared to understand what was necessary to avoid harmful interference, it appears that corners have been cut in the course of deployment," observed ARRL Chief Executive Officer David Sumner K1ZZ. "We can only speculate as to the reasons why they have taken this path, but the fact is that IBEC is not playing by the rules and their systems must cease operation until they are brought into compliance."

For months, amateur operator Kevin Ward K4BDR of Afton, Virginia has experienced harmful interference at his home as well as during mobile operation during his regular commutes to work. The BPL system in his area uses power lines owned by the Central Virginia Electric Cooperative. Complaints to IBEC have been fruitless. Measurements taken in the area of Lovingston and Arrington, Virginia show that the system is operating well in excess of maximum radiated emission limits and without necessary notching. Measurements of radiated emissions from an IBEC system in Martinsville, Indiana using power lines owned by the South Central Indiana Rural Electric Membership Cooperative (SCI REMC) gave similar results.

IBEC systems were observed operating in Somerset, Pennsylvania and Fairfield, Virginia well above permitted radiated emission levels, despite there being no listing in the online BPL database anywhere in the vicinity of these locations.

# FCC Sends License Renewal for K1MAN to Administrative Law Judge

Newington, CT., January 11<sup>th</sup>, 2011 — The FCC has issued a <u>Hearing Designation Order</u> to determine, among other things, if the Amateur Radio license of Glenn A. Baxter K1MAN, of Belgrade Lakes, Maine, should be renewed.

According to the Order, "Baxter has apparently willfully and repeatedly engaged in unlawful Commission-related activities, including causing interference to ongoing communications of other amateur stations, transmitting communications in which he had a pecuniary interest, failing to

file requested information pursuant to an Enforcement Bureau (Bureau) directive, engaging in broadcasting without communicating with any particular station and failing to exercise control of his station."

Baxter, whose amateur license expired in 2005, filed a timely renewal on July 22<sup>nd</sup>, 2005; his license expired on October 17<sup>th</sup>. Because of the timely renewal, Baxter's license remained in effect past the expiration date.

The FCC said it "believe[s] that Baxter's apparent continuing course of misconduct raises a substantial and material question of fact as to whether he possesses the requisite character qualifications to be and remain a Commission licensee."
